### Hazard Identification

**Spillage:** Remove ignition sources. Provide adequate ventilation. Avoid excessive inhalation of vapours.

Gross spillage should be contained immediately by use of sand or inert powder and disposed of according to local regulations.

**Environmental precautions:** Keep away from drains, surface and ground water, and soil.

#### **Handling and Storage**
