Hazard Identification

General: When undiluted and not properly handled, can be irritating to the skin and eyes and upon inhalation.

First Aid Measures

Fire-Fighting Measures

Extinguishing media: carbon dioxide, dry chemical, foam.

Accidental Release Measures

Personal precautions: Avoid inhalation and direct contact with skin and eyes. Use individual protective equipment (safety glasses, waterproof-boots, suitable protective clothing) in case of major spillages.

Spillage: Remove ignition sources. Provide adequate ventilation. Avoid excessive inhalation of vapours.

Gross spillage should be contained immediately by use of sand or inert powder and disposed of according to local regulations.

Environmental precautions: Keep away from drains, surface and ground water, and soil.

Handling and Storage

Precautions in handling: Apply good manufacturing practice and industrial hygiene practices, ensuring proper ventilation. Observe good personal hygiene, and do not eat, drink or smoke whilst handling.

Storage conditions: Store in tightly closed original container, in a cool, dry and ventilated area away from heat sources and protected from light. Keep air contact to a minimum.

Fire protection: Keep away from ignition sources and naked flames. Take precautions to avoid static discharges in working area.

Respiratory protection: Avoid breathing product vapour. Apply local ventilation where possible.

Ventilation: Ensure good ventilation of working area.

Skin protection: avoid skin contact. Use chemically resistant gloves as needed.
