Composition/Ingredients Information

Botanical name : Rosmarinus officinalis
Dried cut rosemary leaf.

Hazards Identification

Not regarded as a health hazard under current legislation.

At First Aid Measures

General: seek medical attention in case of any discomfort.

Storage conditions:
Store in tightly closed original container, in a cool, dry and ventilated area away from heat sources and protected from light. Keep air contact to a minimum. Protect from insect infestation.

Ventilation: provide adequate general and local exhaust ventilation.
Respirators: general facemask.
Gloves: use suitable protective gloves.
Eye protection: wear approved safety goggles.
