**Hazards Identification**

Non hazardous.

**First Aid Measures**

Skin contact: wash material off the skin with copious amounts of soap and water. If irritation develops, seek medical advice.  
Eye contact: immediately flush eyes with copious amounts of water for at least 15 minutes. Do not let victims rub eyes. If irritation persists seek medical attention.
